**Basics to form innovative economic
model of Russian development are as
follows:**



Economy based on generation, dissemination and exploitation of knowledge

- Significant sector of fundamental science (worldwide known organizations of Russian academy of science, as well as Russian universities);
- Ability for conducting R&D and commercialization of the results received via the system of state scientific centers;
- Competitive advantages of Russia in most significant sectors, i. e. aviation, space and nuclear energy;
- Effective system of education, as well as post gradual training of specialists;
- Existence of basic elements of innovation structure, i. e. innovation and technology centers, centers of transfer of technology, specialized funds to support innovation entrepreneurship, including of state, private and venture character



Economy based on generation, dissemination and exploitation of knowledge

Commission for modernization of economy was established under the Russian President.

Activity of the Commission is focused on priority directions, i. e. energy efficiency, space, nuclear, medical and information technologies.

The President has defined five strategic vectors to modernize Russian economy:



Economy based on generation, dissemination and exploitation of knowledge

- 1. To develop and introduce effective production, transportation and use of energy, including development of new sources of energy;**
- 2. To maintain and develop nuclear technologies;**
- 3. To facilitate information technologies to influence processes of global public information net, using super computers and other relevant material basis.**
- 4. To create Russian surface and space infrastructure to transmit all the types of information;**
- 5. To develop production of medical and diagnostic equipment to treat virus, cordial and oncology diseases.**



Economy based on generation, dissemination and exploitation of knowledge

Russian Government is developing the competitive system:

- To finance the consumers of Russian export technologies;
- To increase favorite state crediting of Russian exporters of innovation products;
- To establish insurance system for export credits and investment
- To optimize customs procedures, requirements of currency and export control while exporting innovation products.

- Efficiency of energy and energy saving, including development of innovation energy technologies;
- Nuclear technologies;
- Space technologies, primarily telecommunication and navigation systems, including surface infrastructure;
- Medical technologies, medical equipment and medicines;
- Strategic computer technologies and software.

**The managing company will be defined
by the President of the Russian
Federation to rule the Center**



“SKOLKOVO” – the newest center of Russian innovation

The participants are subject to compensation of customs payments levied on importation of products necessary for R&D in the Center.

They are also subject to simplified accounting and reporting as well as to simplified procedures to invite foreign specialists.

Some tax relief is to be provided.



“SKOLKOVO” – the newest center of Russian innovation

The key instrument of coordination between the participants of the Center and federal authorities is the special status of “the project participant”.

The project participant could be recognized any Russian legal person incorporated solely to conduct R&D, as well as any related activity within the boundaries of the Center.
